## AN ORDINANCE APPROVING ZONE DISTRICT DESIGNATION AMENDMENT AND ZONING DISTRICT MAP AMENDMENT FOR BURKE JACKSON, BILLIE DARLING, DREW DOWNS & BRADLEY LONG

WHEREAS, Burke Jackson, Billie Darling, Drew Downs & Bradley Long, owners of approximately 7 acres located at approximately 649 - 710 West Main and further described by the legal description attached as Exhibit "A", have applied for an amendment to the Zone District Designation and Zoning District Map; and

WHEREAS, the current zone designation of the property is A-1 and RA-1 and said applicants seek to have said parcels designated as NC (Neighborhood Commercial; and

WHEREAS, the request for a Zone District Map Amendment is in compliance with the Lehi City Comprehensive Plan Land Use Map amendment adopted by the Lehi City Council on December 9, 2008; and

WHEREAS, the Lehi City Planning Commission has received input through a Public Hearing before the Planning Commission on November 13, 2008, after appropriate notice as required by State Law; and

WHEREAS, the Lehi City Council has received the Planning Commission's recommendation as well as input through a Public Hearing before the City Council on December 9, 2008, after appropriate notice as required by State Law.

NOW, THEREFORE, IT IS ORDAINED BY THE CITY COUNCIL OF LEHI CITY, UTAH, AS FOLLOWS:

- <u>Section 1.</u> The Zone District Designation of the property owned by Burke Jackson, Billie Darling, Drew Downs & Bradley Long is hereby amended from A-1 & RA-1 to NC and the Zoning District Map is amended to designate said property, in it's entirety, as NC.
- Section 2. This ordinance shall take effect immediately after passage by the City Council and subsequent publication as required by law. However, this ordinance shall not be published and take effect until the water dedication requirement has been met as required in Sec. 27-040-G of the Lehi City Development Code.
