**AMENDMENT TO THE
DECLARATION
OF COVENANTS, CONDITIONS AND RESTRICTIONS OF
MOOSE HOLLOW CONDOMINIUM PROJECT**

RECITALS

WHEREAS, the Declaration of Condominium of the Moose Hollow Condominium Project was recorded on February 25, 1999 as Entry No. 1615984, Book 1994, beginning at Page 2063 in the offices of the Weber County Recorder (hereinafter the "Declaration").

WHEREAS, Article III, Section 42 of the Declaration states that the Declaration may be amended with the approval of at least sixty-five percent (65%) of the undivided ownership interest in the Common Area and Facilities.

WHEREAS, the Declaration was amended through a document entitled, "Amendments to Declaration of Condominium for Moose Hollow Condominium Project Eden, Weber County, Utah", which was recorded on August 6, 2001 as Entry No. 1787249, Book 2158, beginning at Page 1788 in the offices of the Weber County Recorder.

WHEREAS, the Declaration was next amended through a document entitled, "Amendment to the Declaration of Condominium of the Moose Hollow Condominium Project", which was recorded on February 14, 2003 as Entry No. 1913668, Book 2318, beginning at Page 2911 in the offices of the Weber County Recorder.

WHEREAS, the Declaration was next amended through a document entitled, "Amendment to the Declaration of Covenants, Conditions and Restrictions of Moose Hollow Condominium Project", which was recorded on March 29, 2005 as Entry No. 2093635 in the offices of the Weber County Recorder.

WHEREAS, the Declaration was next amended through a document entitled, "Amendment to the Declaration of Covenants, Conditions and Restrictions of Moose Hollow

Condominium Project”, which was recorded on December 29, 2005 as Entry No. 2151469, Book in the offices of the Weber County Recorder.

WHEREAS, the Declaration was next amended through a document entitled, “Amendment to the Declaration of Covenants, Conditions and Restrictions of Moose Hollow Condominium Project”, which was recorded on September 25, 2007 as Entry No. 2294172, Book in the offices of the Weber County Recorder.

WHEREAS, it is necessary to amend the Declaration to improve and protect the insurability of the condominium buildings throughout the Project.

NOW THEREFORE, this Amendment to the Declaration is made and executed by the Management Committee after having first received approval from at least 65% of the undivided ownership interest in the Common Area and Facilities. This Amendment is intended to replace all prior provisions which may be in conflict.

AMENDMENT ONE

Article III, Section 26 is hereby amended to read as follows:

Property Insurance. The Association shall obtain and maintain the insurance specified in this Declaration; provided, however, the Association shall always comply with the insurance requirements of the Act.

a. Hazard Insurance. A "master" or "blanket" type policy of property insurance shall be maintained covering the entire Condominium Project (both Units and Common Areas and Facilities). References herein to a "master" or "blanket" type of policy of property insurance are intended to denote single entity insurance coverage. At a minimum, such "master" or "blanket" policy shall afford protection against loss or damage by fire, by other perils normally covered by the standard extended coverage endorsement, and by all other perils that are customarily covered with respect to projects similar to the Condominium Project in construction, location and use, including, without limitation, all perils normally covered by the standard "all risk" endorsement, where such endorsement is available. Such "master" or "blanket" policy shall be in an amount not less than one hundred percent (100%) of current replacement cost of all elements of the Condominium Project covered by such policy, exclusive of land, foundations, excavation and other items normally excluded from coverage. The insurance policy shall include either of the following endorsements to assure full insurable value replacement cost coverage: (1) a Guaranteed Replacement Cost Endorsement (under which the insurer agrees to replace the insurable property regardless of the cost) and, if the policy includes a coinsurance clause, an Agreed Amount Endorsement (which waives the requirement for coinsurance); or (2) a Replacement Cost Endorsement (under which the insurer agrees to pay up to one hundred percent (100%) of the Property's insurable replacement cost but not more) and, if the policy includes a coinsurance clause, an Agreed Amount Endorsement (which waives the requirement for coinsurance). The maximum deductible amount for such policy shall be determined by the Management Committee.

b. Flood Insurance. If any part of the Condominium Project is or comes to be situated in a Special Flood Hazard area as designated on a Flood Insurance Rate Map, a "master" or "blanket" policy of flood insurance shall be maintained covering the Condominium Project, any machinery and equipment that are not part of a building and all Common Area and Facilities within the Condominium Project ("Insurable Property") in an amount deemed appropriate, but not less than the lesser of: (i) the maximum limit of coverage available under the National Flood Insurance Administration Program for the Insurable Property within any portion of the Condominium Project located within a designated flood hazard areas; or (ii) one hundred percent (100%) of the insurable value of the Insurable Property. The maximum deductible amount for such policy covering the Common Areas and Facilities shall be determined by the Management Committee.

c. The name of the insured under each policy required to be maintained by the foregoing (a) and (b) shall be the Association for the use and benefit of the individual Owners (the Owners shall be designated by name, if required). Notwithstanding the requirement of the immediately foregoing sentence, each such policy may be issued in the name of an authorized representative of the Association, including any Insurance Trustee with whom the Association has entered into an insurance trust agreement, or any successor to such Insurance Trustee, for the use and benefit of the individual Owners. Loss payable shall be in favor of the Association (or Insurance Trustee). Each Owner and each Owner's Lender, if any, shall be beneficiaries of such policy. Evidence of insurance shall be issued to each Owner and Lender upon request.

d. Each policy required to be maintained by the foregoing items (a) and (b) shall contain the standard mortgage clause, or equivalent endorsement (without contribution), commonly accepted by private institutional mortgage investors in the area in which the Condominium Project is located.

e. Each policy required to be maintained by the foregoing items (a) and (b), shall provide, if available, for the following: recognition of any insurance trust agreement; a waiver of the right of subrogation against an Owner individually; the insurance is not prejudiced by any act or neglect of an individual Owner which is not in the control of such Owner collectively; and that the policy is primary in the event the Owner has other insurance covering the same loss. However, the Owner's insurance policy applies to that portion of the loss attributable to the Association's policy deductible. The Association may assess a Unit Owner, including by the filing of a lien and enforcing the lien in the same manner as regular common expense assessments, for the portion of the loss attributable to the Association's policy deductible if the Unit Owner does not have a policy to cover the Association's policy deductible.

f. If, in the exercise of the business judgment rule, the Committee determines that a claim is likely not to exceed the Association's policy deductible, the Unit Owner's policy is considered the policy for primary coverage to the amount of the deductible; and the Association need not tender the claim to the Association's insurer.

AMENDMENT TWO

Article III, Section 12 of the Declaration is hereby amended by adding the following provision as subsection (k).

"k. The power and authority, upon reasonable notice of at least 24 hours, except for in an emergency in which case notice is not necessary, to enter into any Unit to abate any infractions, check smoke and carbon monoxide detectors (which every Unit is required to have), check to ensure the heat is set to a minimum of fifty-five (55) degrees so as to prevent frozen pipes during the cold season, to make repairs or correct any violation of any of the provisions of this Declaration, and in connection therewith shall have the further right to assess all costs and expenses incurred against the Unit. Such costs and expenses are to be treated as an assessment subject to the nonpayment remedies provided in Article III, Section 24 of the Declaration. Any entry performed under this Section shall not constitute a trespass."

AMENDMENT THREE

Article III, Section 10 is hereby amended to read as follows:

"10. **Condition and Maintenance of Units and Limited Common Areas.** Each Unit shall be maintained by the Owner thereof so as not to detract from the appearance of the Project and so as not to affect adversely the value or use of any other Unit or other portions of the Project. **Each Unit shall have an operable Smoke and Carbon Monoxide Detector. Each Unit must be heated to a temperature of no less than fifty-five degrees (55° F) at all times to prevent pipes from freezing. For Units wherein the gas is turned off, the Committee may in its sole discretion, set up and pay for the gas utility to that Unit. All costs and expenses incurred by the Association as a result, shall be assessed against that Unit subject to the nonpayment remedies provided in Article III, Section 24.** Each Unit Owner shall keep his storage space and his appurtenant decks(s) in a clean and orderly condition, but shall not otherwise maintain the same. The Committee shall have no obligation regarding maintenance or care which is requested to be accomplished by Owners.

Each Unit Owner (or occupant of any Unit), not the Association, nor the Committee, shall be responsible for consequences resulting from the intoxication or other improper conduct of his invitees.

Each Unit Owner shall be liable to the Association, or other Owners or occupants, for damages to person or property and waste in the Project caused by his or her (or his or her tenants') negligence."

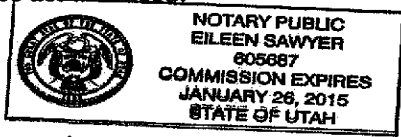
