For one pole on your property at your gravel pits, North Salt Lake, described as follows, to wit:

In the Northeast quarter, Southeast quarter, Section 23, Township 1 North, Range 1 West, S. L. B. & M. as shown on drawing U.A. 12472, attached

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.
