A RESOLUTION CREATING AN AGRICULTURE PROTECTION AREA NORTH OF 700 SOUTH BETWEEN 2100 WEST AND 2800 WEST, CONTAINING 183.411 ACRES

WHEREAS State Statute ~~17-4~~ provides regulations for land to be protected for agriculture purposes; and 17-41

WHEREAS an application for such protection was filed in the Syracuse City Office on December 14, 1999 by E. Burton Johnson, representing the L.D.S. Church; and

WHEREAS the application meets the requirements of State Statute and Syracuse City Ordinance; and

WHEREAS the City Council has failed to reject the proposal within 120 days after submission;
