AMENDMENT TO DECLARATION OF BUILDING AND USE RESTRICTIONS

WHEREAS, on the 22nd day of September, 1980, there was recorded in the office of the County Recorder of Salt Lake County, Utah, as Entry No. 3480189, in Book 5153, at page 877, a document entitled Declaration of Building and Use Restrictions for Lots 101 to 135, inclusive, WEST HILLS NO. 2, PHASE I, and Lots 201 to 242, inclusive, WEST HILLS, NO. 2, PHASE II, according to the official plats thereof recorded in the office of the County Recorder of said County.

WHEREAS, it is deemed necessary and for the best interests of the subdivision and the occupants thereof that said Declaration of Building and Use Restrictions be amended to correct Paragraph three (3) of Part "B", Residential Area Covenants.

NOW, THEREFORE, the undersigned, BARTLEY K. CURTIS, MARCUS LEE ZAROGOZA and SHARON E. ZAROGOZA, husband and wife, EDWARD G. NIELSEN and BARBARA NIELSEN, husband and wife, AMERICAN SAVINGS & LOAN ASSOCIATION, and UTAH C. V. FEDERAL CREDIT UNION, the fee owners of Lots 101 to 135, inclusive, WEST HILLS NO. 2, PHASE I, and Lots 201 to 242, inclusive, WEST HILLS NO. 2, PHASE II, according to the official plats thereof recorded in the office of the County Recorder of said County, do hereby amend the Declaration of Building and Use Restrictions recorded in said Book 5153, Page 877, and hereinabove referred to as follows:

3. Dwelling Cost, Quality and Size. No dwelling shall be permitted on any lot at a cost of less than \$30,000.00 exclusive of lot, based upon cost levels prevailing on the date these covenants are recorded, it being the intention and purpose of the covenants to assure that all dwellings shall be of a quality of workmanship and materials substantially the same or better than that which can be produced on the date these covenants are recorded at the minimum cost stated therein for the minimum permitted dwelling size. The main floor area of the main structure, exclusive of one-story open porches and garages, shall be not less than 825 square feet.

EXCEPT as herein amended all of the Restrictions as set forth in

said Book 5153, Page 877, are hereby confirmed and approved.
