SALT LAKE CITY CORPORATION, a municipal corporation of the State of Utah, whose mailing address is 451 South State Street, Rm. 245, Salt Lake City, Utah 84111, "GRANTOR", hereby quit claims to SCHNEIDER PROPERTIES, LLC as "GRANTEE", for the sum of TEN AND NO/100THS DOLLARS (\$10.00), and other good and valuable consideration, all of the City's right, title and interest in and to parcels of land described below, which closes a certain public alleyway, pursuant to Petition No. 400-96-94, by action of Ordinance No. 6 of 1996, published on March 1, 1997 and Petition No. 400-02-26, by action of Ordinance No. 5, published on or about March 31, 2003, respectively described as follows:

Commencing at the Southwest Corner of Lot 1, Block 2 of the Columbia Subdivision, a subdivision of Block 22, Five Acre Plat "A", Big Field Survey, located in the Southwest Quarter of Section 7, Township 1 South, Range 1 East, Salt Lake Base & Meridian; thence North 120 feet to a point 7.9 feet North from the Southwest Corner of Lot 5 of said subdivision; thence West 16.5 feet to a point 7.9 feet North of Lot 18 of said subdivision; thence South 120 feet to the Southeast Corner of Lot 22; thence East 16.5 feet to the point of beginning.

Commencing at the Northwest Corner of Lot 9, Block 4 of the Columbia Subdivision, a subdivision of Block 22, Five Acre Plat "A", Big Field Survey, located in the Southwest Quarter of Section 7, Township 1 South, Range 1 East, Salt Lake Base & Meridian; thence South 421.2 feet to a point 7.9 feet from the Southwest Corner of Lot 5, Block 2 of said subdivision, thence West 16.5 feet to a point 7.9 feet North of the Southeast Corner of Lot 18 of said subdivision; thence North 421.2 feet to the Northeast Corner of Lot 10, Block 4 of said subdivision; thence East 16.5 feet to the point of beginning.
