NO-BUILD AGREEMENT

THIS NO-BUILD AGREEMENT (this "Agreement") is made and entered into as of the 4 day of February, 2004 by and among SCHNEIDER PROPERTIES, LLC, a limited liability company ("Nate Wade"), and SCHNEIDER PROPERTIES, LLC, a limited liability company ("Schneider").

WHEREAS, Schneider Tract and Nate Wade Tract lie within the jurisdiction of Salt Lake City, Utah (the "City"), which is the enforcing authority for the International Building Code, 2000 Edition (the "Code");

NOW, THEREFORE, in consideration of the foregoing recitals and the mutual covenants and promises herein contained, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Nate Wade and Schneider hereby agree as follows:

1. No-Build Area. Nate Wade and Schneider hereby declare and covenant to each other and to the City that the real property described on EXHIBIT C attached hereto and made a part hereof, shall be maintained a "public way" or "yard" as such terms are defined in the Code. As presently defined by the Code, no buildings or other structures (but excluding driveways, sidewalks, curb and gutter, parking, landscaping, and similar uses which do not constitute a building as contemplated by the Code) shall be constructed or permitted to exist on that portion of the Schneider Tract that is located within the No-Build Area defined herein.
