AMENDMENT TO

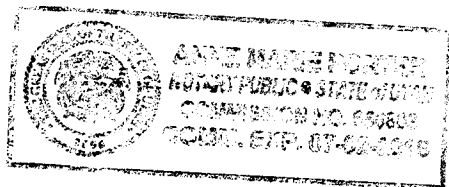
