AMENDMENT TO DECLARATION OF BUILDING AND USE RESTRICTIONS
AND AUTHORIZATION TO AMEND PLAT

DA-018-0001 to 0074

The undersigned, each of whom owns one or more of the 74 lots in CHASE LANE WEST PLAT "A", a subdivision of parts of Sections 6 and 8, Section 7, Township 2 North, Range 1 East, Salt Lake Base & Meridian, Centerville City, Davis County, Utah, hereby amend the Declaration of Building and Use Restrictions pertaining to said Lots 1 through 74 of Chase Lane West Plat "A" dated May 5, 1978, recorded May 9, 1978 in Book 706, Page 518 as Entry No. 495175. Said Amendment affects only the first sentence of paragraph 1 of PART B. RESIDENTIAL AREA COVENANTS which is hereby amended respecting Lot 73 only to read as follows:

1. Land Use and Building Type. No lot, except original lot 73 which may be used as a street, shall be used except for residential purposes.

The undersigned mutually agree that Chase Lane West Plat "A" should be amended to delete Lot 73 as a residential lot and to depict a continuation of 1250 North Street through the area of said Lot 73 to the East line of said Plat. For such purposes, the undersigned do hereby constitute and appoint JOEL HALE as their attorney-in-fact with full power and lawful authority to prepare, execute and record an amendment to said Plat accomplishing said purpose.

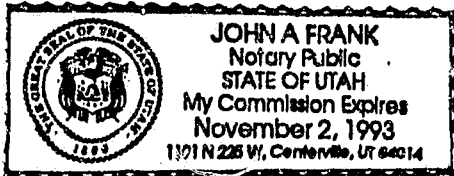
