POLE LINE EASEMENT

Zions Securities Corporation, a corporation doing business in the State of Utah, Grantor, hereby conveys and warrants to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns and licensees, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a ~~perpetual~~ easement and right of way for the erection and continued maintenance, repair, alteration, and replacement of the electric transmission, distribution, and telephone circuits of the Grantee, and one guy anchor and 4 poles, with the necessary guys, stubs, crossarms and other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and maintained on, under, upon and across the premises of the Grantor, in Salt Lake County, Utah along a line described as follows:

Beginning at an existing pole on the Grantors' land at a point 275 feet south and 1040 feet west, more or less, from the north one quarter corner of Section 25, T. 1 S., R. 1 W., S.L.M., thence N. 9° 53' W. 1287 feet on said land and being in the NE 1/4 of the NW 1/4 of said Section 25 and the SE 1/4 of the SW 1/4 of Section 24, Township and Range aforesaid.

Except from the above that portion of line over, across and/or upon Utah State Road right of way.

*The Power Co. will remove or relocate the line when requested.*

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.
