EASEMENT

Beginning at the northeast corner of Lot 7, Block 54, Plat "B", Salt Lake City Survey, thence west along the north line of said Lot 7, a distance of 205 feet; thence south 8.5 feet; thence east 205 feet; thence north 8.5 feet to place of beginning;

for the purpose of constructing, maintaining, repairing and replacing a 6 inch water main along Bueno Avenue west from 8th East Street, together with the right of ingress and egress therefor.

The GRANTEE agrees to do as little damage as possible to the land of Grantors and will level off and replace the surface of the right of way and easement in as nearly the same condition as when disturbed, and within a reasonable time and agrees that said Grantors and their successors and assigns in interest may use the surface of said right of way and easement for any purpose that will not conflict with the rights and privileges hereby granted and conveyed to the Grantee.
