AMENDMENT TO RESTRICTIONS

KNOW ALL MEM BY THESE PRESENTS:

The undersigned owners of the following described property situate in Weber County, Utah, to-wit:

All Lots in HIDDEN VILLAGE SUBDIVISION, according to the official plat thereof, recorded in the office of the County Recorder of said County.

do hereby amend those certain "Restrictions" recorded September 5, 1958 in Book 589 Page 311 of Official Records as follows:

Paragraph "H" is hereby amended to read as follows:

"H. No noxious or offensive trade or activity shall be carried on upon any lot, nor shall anything be done thereon which may be or become an annoyance or nuisance to the neighborhood. The maximum heights of any fence shall be six feet and shall not extend beyond the front setback of the dwelling, provided however, that the building committee shall have power to grant variances for retaining walls to extend beyond the front setback line."




