AMENDMENT TO RESTRICTIONS OF THOSE CERTAIN DECLARATION OF BUILDING AND USE RESTRICTIONS AFFECTING OQUIRRH SHADOWS NO. 15, OQUIRRH SHADOWS PHASE 16A, OQUIRRH SHADOWS PHASE 16B, OQUIRRH SHADOWS PHASE 16C, OQUIRRH SHADOWS PHASE 16D, OQUIRRH SHADOWS NO. 20, OQUIRRH SHADOWS NO. 21, and OQUIRRH SHADOWS NO. 22.

The undersigned, being the owner of the subdivisions hereinafter set forth, is desirous of amending Part B, Residential Area Covenants, Paragraph 3, which were recorded in the office of the County Recorder of Salt Lake County, State of Utah, as hereinafter set forth, to read as follows:

3. Dwelling Costs, Quality and Size.

No dwelling shall be permitted on any lot at a cost of less than \$43,000.00, including lot, based upon cost levels prevailing on the date these covenants are recorded, it being the intention and purpose of the covenants to assure that all dwellings shall be of a quality of workmanship and materials substantially the same or better than that which can be produced on the date these covenants are recorded at the minimum cost stated herein for the minimum permitted dwelling size. The main floor area of the main structure, exclusive of one-story open porches and garages, shall be not less than 850 square feet, the main floor area being the total of the 2 levels above the foundation of a two-story structure.

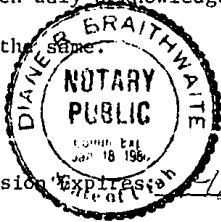
