

ILC and Gen and their respective successors, assigns and invitees shall have a continuing right to access the ILC Parcel by means of the existing ~~dir~~ road and bridge other than for heavy construction equipment.

2. Runway. There is a runway on the ILC Parcel which has been used by Winkler. The runway is shown on the Survey. Owners agree that they have no further right to use the runway and that ILC or Gen shall have the right to reclaim the ILC land on which the runway is situated at such time and in such manner as ILC or Gen may determine.

3. Gas Line. There is a gas line serving the Winkler Parcel as shown on the Survey, and an electric line is located within that easement. Owners agree that the gas ~~line~~ and electric lines may be removed and the easement vacated ~~at such time as~~ after ILC or Gen has constructed or caused to be constructed ~~an adequate gas line~~ and electric lines serving the Winkler Parcel in compliance with the requirements of Wasatch County.

4. Temporary Ingress and Egress Easement. The Winkler Parcel is served by a temporary ingress and egress easement situated on the ILC Parcel as identified on the Survey. The Owners agree that the roadway may be removed and the easement vacated at such time as ILC or Gen has constructed or caused to be constructed paved public roadway and utility access serving the Winkler Parcel in compliance with requirements of Wasatch County.

5. Fence Line Encroachments. Certain fences constructed by Winkler encroach upon the ILC Parcel as shown on the Survey. Owners agree ~~to~~ that ILC or Gen may remove or relocate ~~such~~ the portions of the fences ~~off~~ located on the ILC property ~~within a reasonable period following a request from ILC or Gen that they do so~~.

6. Overflow Pipeline. There is an overflow pipeline easement running between the Wasatch Canal and Timpanogos Canal as shown on the Survey. Owners acknowledge and agree that they have no objection to the vacation of the easement and that they will cooperate with ILC and Gen in connection therewith.

7. Irrigation Pipelines. There are certain irrigation pipelines associated with the Wasatch County Water Efficiency Project ("WCWEP") as shown on the Survey. ILC or Gen may desire to relocate such pipelines and easements. Owners acknowledge and agree that they have no objection to such relocation and that they will cooperate with ILC and Gen in connection therewith; provided, however, that irrigation service in compliance with WCWEP requirements is maintained to the Winkler Parcel ~~is maintained~~.

8. Further Assurances. Each party hereto agrees to execute such releases, relinquishments, and other documents as may reasonably be required in order to effectuate the purposes of this Agreement.

9. Successors and Assigns. This Agreement shall be binding upon and inure to the benefit of the respective heirs, personal representatives, successors and assigns of the parties.


