### SUPPLEMENTAL BY-LAWS OF WHITTIER ESTATES SUBDIVISION

#### KNOW ALL PERSONS BY THESE PRESENTS:

WHEREAS, it is necessary and desirable that the Bylaws be supplemented;

NOW THEREFORE, pursuant to a motion presented and duly carried and approved by a quorum of 76% of the Owners at the annual meeting of the Owners Association (the "Association") on the 13<sup>th</sup> day of January, 2021, and in consideration of the promises, agreements, and considerations, herein contained, IT IS HEREBY AGREED that the following Bylaws shall be, and the same are, hereby amended as follows:

Article I: OFFICES: is amended in its entirety as follows:

### **Article I-offices**

The principal office of the Association shall be the address of the Association's Management Company, &/or the registered address with the Division of Corporations and Commercial Business Search.

Article IV B.: Number, Tenure, and Qualifications: is amended in its entirety as follows:

## Article IV-Board of Directors

B. Number, Tenure, and Qualifications. The number of directors of the Association is a minimum of three but no more than five. At least two directors shall be Owners, or an owner, officer, employee, director, trustee, member, or general partner of an Owner which is a corporation, trust, limited liability company, or partnership. Directors will hold office for 2 years and until there successor is elected and has qualified, or until removed, if removed pursuant to Section IV.D.

These Supplemental Bylaws incorporate herein by reference, to the extent not inconsistent, the terms and conditions of the Bylaws and all terms thereof shall be binding upon Whitter Estates Home Owners Association.

These Supplemental Bylaws and every provision hereof shall take effect upon recording.
