There are no liens against the land designated as Tracts No. 1-4, except the following: N/A

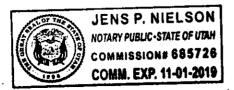

INDEMNITY AGREEMENT Change of Place of Use

This Agreement dated this 30 day of Navember, 2017, The Banana Farm, LLC, hereinafter referred to as the Owner, and the STRAWBERRY WATER USERS ASSOCIATION, AND THE West Field Canal COMPANY.

WHEREAS: The OWNER has 29.06 acre feet of Strawberry Project Water, Serial No. 2099.001, 2099.002, 2099.003, 2084.001, 2084.002, 2085.002, 2085.003, 2085.004, 2119.003 and 2119.004, which they are desirous to transfer from Project lands owned by them, and described in the attached instrument,

The Owner hereby covenants and agrees as follows:

In the event that the Owner has the land, upon which the Project Water is appurtenant, encumbered by a mortgage or other encumbrance, and in the event the said land is sold or foreclosed upon and the Project water should be claimed by other individuals, the Owner hereby agrees and covenants that they will hold the Strawberry Water Users Association and the West Field Canal Company harmless from any actions which will include all damages, attorney's fees and all costs which may be expended by said Strawberry Water Users Association or the Canal Company.
