POLE LINE EASEMENT

Edward M. Gardiner and Florence E. Gardiner
his wife, Grantor.s, of Weber County, Utah, hereby convey... and warrant...
to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns,
Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement
and right of way for the erection and continued maintenance, repair, alteration, and replacement
of the electric transmission, distribution and telephone circuits of the Grantee, and
one guy anchors and two poles, with the necessary guys, stubs, crossarms and
other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and
maintained upon and across the premises of the Grantor.s, in Weber County,
Utah, along a line described as follows:

Beginning at a point on the west line of Wall Avenue N. 89° 46' 20" W. 524.92
feet along the quarter section line and S. 0° 58' W. 1159.29 feet from the
northeast corner of the Southwest Quarter of section 5, T. 5 N., R. 1 W., S.L.M.,
thence N. 83° 16' W. 257.27 feet, thence S. 12° 00' W. 5 feet, thence S. 83° 16' E.
258.24 feet, thence N. 0° 58' E. 5 feet to the point of beginning.

This easement cancels and supersedes that certain easement contracted
between Edward M. and Florence E. Gardiner, Grantors, and Utah Power & Light
Company, Grantee, dated August 14, 1944 and recorded as Instrument No. 87956
Book 199 of leases, page 382, in the office of the County Recorder of Weber
County, State of Utah.

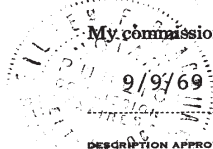
