Right Of Way Deed

Gomer A. Nicholas, of Marcia Ann Nicholas grantors
 of Capitan County of Cherokee State of Utah,
 hereby grants, bargains and sells to the STATE ROAD COMMISSION OF UTAH, Grantee, for
 the sum of One Hundred Twenty Five DOLLARS,
 the following described strip or parcel of land, as a perpetual right of way for highway purposes
 across the grantors land in Keter County, State of Utah, as follows:

Right of way for highway known as State Route No. U-204 across the grantors land in the $\frac{22\frac{1}{2}}$ $\frac{5\frac{1}{2}}$ of Section 5, T. 5 N., R. 1 W., S. 1. N. Said right of way is contained within a parcel of land, the boundaries of which are described as follows:

Beginning at the intersection of the northerly boundary line produced of said grantors land and the center line of survey of said highway at Engineer's Station 4.33, which point is 474.9 ft. westerly along the $\frac{2}{3}$ section line and 1769.7 ft. $S.0^{\circ}58'W.$, along said center line of survey from the northeast corner of the $\frac{22\frac{1}{2}}$ of said Section 5; thence $S.63^{\circ}04'E.$, 39.3 ft. to the center line of the Riverdale road; thence $S.38^{\circ}06'W.$, 77 ft. along said road; thence $N.83^{\circ}04'W.$, 68.2 ft.; thence $N.6^{\circ}45'E.$, 65.9 ft. to said northerly boundary line of the grantors land; thence $S.53^{\circ}04'W.$, 69.0 ft. to the point of beginning as shown on the official map of said highway on file in the office of the State Road Commission of Utah. Above described parcel of land contains 0.13 acre, of which 0.09 acre is now occupied by the existing highway. Balance 0.04 acre.

In executing this deed, the grantor hereby grants to the State Road Commission of Utah, permission to relocate and reconstruct within the grantors land and outside the limits of above described right of way, all irrigation ditches existing within said limits of above described right of way, and to extend onto said grantors land and outside the limits of the above described right of way, all cut and fill slopes made necessary by the grading for sidewalks on said right of way.


