## EASMENT

Survey and running thence North 84° West 8.18 chains more or less to the East boundry of Wall Avenue in Ogden City, Utah, running thence South along the East boundry of said Wall Avenue 8 feet; thence South 84° East 8.18 chains more or less to a point 8 feet South of the point of beginning; thence North to the point of beginning.

It being agreed that the grantee shall have free access to the said property and sufficient of the surrounding property to
