## NOTICE OF REINVESTMENT FEE COVENANT

(North Pointe Townhomes Phase 2)

Pursuant to Utah Code Ann. § 57-1-46(6), the North Pointe Townhomes Association ("Association") hereby provides this Notice of Reinvestment Fee Covenant which burdens all of the real property described in Exhibit A (the "Burdened Property"), attached hereto, which is subject to the Declaration of Covenants, Conditions, and Restrictions for North Pointe Townhomes recorded with the Utah County Recorder on September 17, 2018 as Entry No. 89017:2018, and any amendments or supplements thereto (the "Declaration").
