BEGINNING at a point 333.06 feet south of the northwest corner of Lot 53, GLENDALE PARK SUBDIVISION; thence east 800 feet, more or less, thence southeasterly 1700 feet, more or less, to a point about 400 feet west of the center of the intersection of Navajo Street and Illinois Avenues; thence southeasterly 1700 feet, more or less, to about the center of the intersection of Concord Street and California Avenue, excepting where said right of way crosses public streets, avenues or alleys, or Block 2 of SENIOR'S BURLINGTON ADDITION, a subdivision of Lots 87 and 88 of said GLENDALE PARK SUBDIVISION.

The above is a Centerline description of a 66.0 feet wide easement and right of way for a drain ditch known as C. W. A. Drain Ditch No. 1.

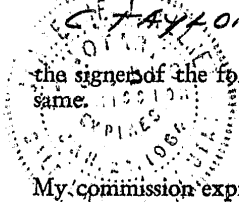

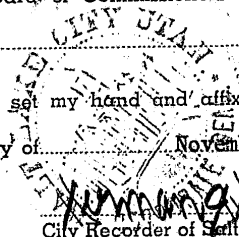
