SUPPLEMENT TO PROTECTIVE COVENANTS

PLAT OF CANDLESTICK PARK
SALT LAKE COUNTY, STATE OF UTAH

KNOW ALL MEN BY THESE PRESENTS:

THAT the following changes to Section 6 of the Protective Covenants and Restrictive Covenants shall apply:

6. No structure shall be erected nearer than twenty-five (25) feet to the front residential lot line; however, customary architectural appurtenances such as cornices, bay windows, steps, spouts, chimneys, planter boxes, covered or uncovered porches, excluding enclosed porches, may extend an additional five (5) feet nearer the front lot line. No dwelling house shall be located nearer than eight (8) feet to the side line of a residential lot on one side and ten (10) feet on the opposite side; provided, however, that a garage may be erected within two (2) feet from the side lot line. No house or garage or other structure may be erected or constructed nearer than ten (10) feet to an existing building or structure already erected or in the process of construction on any adjoining lot. No building or structure shall be erected nearer than five (5) feet to the rear property lot line. No residential structure shall be erected on any lot which has an area of less than seven thousand (7,000) square feet or a width of less than sixty (60) feet at the building front set-back line.

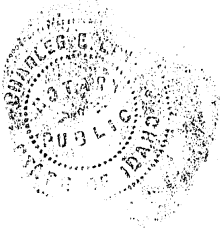
