**FIRST SUPPLEMENT TO DECLARATION  
OF  
COVENANTS, CONDITIONS AND RESTRICTIONS OF HIDDEN CREEK,  
a Utah planned unit development**

THIS FIRST SUPPLEMENT TO THE DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS FOR HIDDEN CREEK is made and executed by HIDDEN CREEK, L.L.C., a Utah limited liability company, whose principal address is 8438 South Gad Way, Sandy, Utah 84093 (hereinafter referred to as the "Declarant").

**RECITALS**

Whereas, the original Declaration of Covenants Conditions and Restrictions was recorded in the office of the County Recorder of Salt Lake County, Utah on the 15th day of February, 2002 as Entry No. 8153003 in Book 8567 at Page 565 of the Official Records of the County Recorder of Salt Lake County, Utah (the "Declaration").

Whereas, the related Plat Map(s) for Phases I and II of the Project has also been recorded in the office of the County Recorder of Salt Lake County, Utah.

Whereas, the First Amendment to the Declaration was recorded in the office of the County Recorder of Salt Lake County, Utah on the 8th day of May, 2002 as Entry No. 8226896 in Book 8595 at Page 9046 of the Official Records of the County Recorder of Salt Lake County, Utah (the "First Amendment").

Whereas, the Second Amendment to the Declaration was recorded in the office of the County Recorder of Salt Lake County, Utah on the \_\_\_\_\_ as Entry No. \_\_\_\_\_ in Book \_\_\_\_\_ at Page \_\_\_\_\_ of the Official Records of the County Recorder of Salt Lake County, Utah (the "Second Amendment").

Whereas, under Article III, Section 49 of the Declaration, Declarant reserved an option until the seven (7) years from the date following the first conveyance of a Lot in Phase I to a Lot purchaser to expand the Project in accordance with the Act.

Whereas, Declarant is the fee simple owner of record of that certain real property located in Salt Lake County, Utah and described with particularity on Exhibit "A-3" attached hereto and

incorporated herein by this reference (the "Phase III Property") and Exhibit "A-4" attached hereto and incorporated herein by this reference (the "Phase IV Property").

Whereas, Declarant desires to expand the Project by creating on the Phase III and Phase IV Property a planned residential development.

Whereas, Declarant now intends that the Phase III and Phase IV Property shall become subject to the Declaration.

NOW, THEREFORE, for the reasons recited above, and for the benefit of the Project and the Lot Owners thereof, Declarant hereby executes this First Supplement to the Declaration of Covenants, Conditions and Restrictions for Hidden Creek.

1. Supplement to Definitions. Article I of the Declaration, entitled "Definitions," is hereby modified to include the following supplemental definitions:

A. First Supplemental Declaration shall mean and refer to this First Supplement to the Declaration of Covenants, Conditions and Restrictions for Hidden Creek.

B. First Supplemental Phase III and Phase IV Map shall mean and refer to the Supplemental Plat Maps of Phase III and Phase IV of the Project, prepared and certified to by L. Mark Neff, a duly registered Utah Land Surveyor holding Certificate No. 172065, and filed for record in the Office of the County Recorder of Salt Lake County, Utah concurrently with the filing of this First Supplemental Declaration.

Except as otherwise herein provided, the definition of terms contained in the Declaration are incorporated herein by this reference.

2. Legal Description. The real property described in Exhibits A-3 and A-4 is hereby submitted to the provisions of the Act and said land shall be held, transferred, sold, conveyed and occupied subject to the provisions of this Supplemental Declaration:

3. Annexation. Declarant hereby declares that the Phase III and Phase IV Property shall be annexed to and become subject to the Declaration, which upon recordation of this First Supplemental Declaration shall constitute and effectuate the expansion of the Project, making the real property described in Exhibits A-3 and A-4 subject to the functions, powers, rights, duties and jurisdiction of the Association.

4. Total Number of Lots Revised. As shown on the Phase III Map, fifteen (15) Buildings and seventy (70) additional Lots are or will be constructed and/or created in the Project on the Phase III Property.

As shown on the Phase Phase IV Map, twelve (12) Buildings and fifty-two (52) additional Lots are or will be constructed and/or created in the Project on the Phase IV Property.

The additional Buildings and Lots are located within a portion of the Additional Land. The additional Buildings and Lots are substantially similar in construction, design and quality to the Buildings and Lots in the prior Phases. Upon the recordation of the Phase III and Phase IV Maps and this First Supplemental Declaration, the total number of Lots in the Project will be two hundred and sixteen (216).

5. Percentages of Ownership Interest Revised. Pursuant to the Act and the Declaration, Declarant is required, with the additional Lots, to reallocate the undivided percentages of ownership interest in the Common Areas and Facilities (the "Percentage Interests"). The percentages of ownership interest are uniform and equal. Exhibit "B" to the Declaration is deleted in its entirety and "Revised Exhibit "B", attached hereto and incorporated herein by this reference, is substituted in lieu thereof.

6. Effective Date. The effective date of this First Supplemental Declaration and the Phase III and Phase IV Maps shall be the date on which said instruments are filed for record in the Office of the County Recorder of Salt Lake County, Utah.

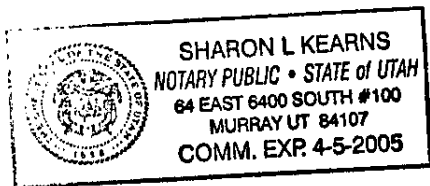
