**ADMINISTRATIVE DETERMINATION AMENDMENT**

**WHEREAS**, it has been determined that an additional access for Fireside Drive, a county road, needs to be created along the Limited Access Line of SR-32, UDOT Project SP-1776.

The Utah Department of Transportation, having rights of jurisdiction over highways in the State of Utah per Utah State Code § 72-1-201 and Utah State Code § 72-3-102 as amended, wishes to create the End L/A and Begin L/A points in the existing southerly Highway Right of Way and Limited Access Line.

**WHEREAS**, it is the determination of the Utah Department of Transportation that the opening in the Highway Right of Way and Limited Access lines be created for the safety and welfare of the traveling public and the welfare of the State of Utah.

**WHEREAS**, the limits for said Fireside Drive access opening in the Highway Right of Way and Limited Access lines being created for UDOT Project No. SP-1776 are shown on right of way plan sheet number 17, on the official map of said project on file in the office of the Utah Department of Transportation, shall be as follows:

The Utah Department of Transportation wishes to create the End L/A and Begin L/A points for SR-32 over and across the southerly Highway Right of Way and Limited Access Line for One (1) 60 foot section, which centers at a point directly opposite Highway Engineer Station 345+82 with the **End L/A** at engineer station **345+52** and the **Begin L/A** at engineer station **346+12**. The center of said 60-foot section is located approximately 657.62 feet N.61°52'51"W. from the North quarter corner of Section 2, Township 3 South, Range 5 East, Salt Lake Base & Meridian.

Said 60.00 foot break in the southerly Highway Right of Way and Limited Access Line being located at Highway Engineer Station 345+82 and is subject to the relinquishment of the existing two (2) 16-foot agricultural access openings (1) centered at approximate Highway Engineer Station 331+00 as granted in that certain Quit Claim Deed recorded as Entry No. 165154 in Book 255 at Page 405 in the office of the Wasatch County Recorder, Utah, but as shown on the official plans of said project and as at a point opposite Highway Engineer Stations 333+50 and (2) centered at approximate Highway Engineer Station 347+31 as granted in that certain Quit Claim Deed recorded as Entry No. 165154 in Book 255 at Page 405 in the office of the Wasatch County Recorder, Utah, but as shown on the official plans of said project and as at a point opposite Highway Engineer Stations 364+50.

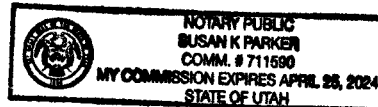
