ACCESS EASEMENT AGREEMENT

An Access Easement Agreement (the "Agreement") dated <u>1 October, 2004</u> by and between <u>Canal East, L. C. (he</u>reinafter referred to as "East") a Utah limited liability company, and <u>Canal West, L. C. (he</u>reinafter referred to as "West") a Utah limited liability, collectively referred to as the "Parties".

RECITALS

East and West are the equitable owners of Lots 316 and 317, Jordan Industrial Center Phase III Subdivision, situated in Salt Lake County, Utah. Upon the terms and conditions set forth herein, the parties are desirous of creating a shared easement for access. $21-31-453-\infty3$

NOW THEREFORE, in consideration of the premises set forth herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. Grant of Access Easement. Subject to the rights and restrictions hereinafter set forth, the parties hereby jointly create and grant to each other, themselves, and their successors, assigns, and heirs a perpetual non-exclusive access easement across the portion of the following property that is currently used as driveways and drive approaches, that is currently paved with asphalt and not including that used as parking stalls:

2. Maintenance. The titleholder of each half of the easement shall be obligated to maintain that half of the easement in good condition and repair.

Each party shall indemnify, defend and save the other party harmless from any and all liability, damage, expense, causes of action, suits, claims or judgments arising from injury to person or property caused by them, their employees, agents and business invitees, except if caused by the party seeking indemnification.
