DEED OF EASEMENT

HAROLD J. DAWSON and DORIS M. DAWSON, husband and wife, of Layton, County of Davis, State of Utah, hereinafter referred to as Grantor, hereby conveys to THE UNITED STATES OF AMERICA, acting pursuant to the provisions of the Act of June 17, 1902, (32 Stat. 388) and acts amendatory thereof or supplementary thereto, Grantee, for the sum of One Dollar (\$1.00), a perpetual easement to construct, reconstruct, operate and maintain an underground pipeline or pipelines and appurtenant structures which latter may protrude above the ground surface on, over or across the following described property in Davis County, State of Utah:

A strip of land in the Southeast Quarter of the Southeast Quarter (SE 1/4) of Section Eleven (11), Township Four (4) North, Range One (1) West, Salt Lake Base and Meridian, Twenty (20) feet wide and included between two lines extended to the property lines and every-where distant Fifteen (15) feet on the right or northerly and Easterly sides and Five (5) feet on the left or southerly and Westerly sides of that portion of the following described centerline of what is known as the North Davis Lateral 3.2 from Station 0+23.7 to Station 5+55.0 measured at right angles thereto; said centerline is more particularly described as follows:

Beginning at Station 0+23.7, a point on the South line of the Grantor's property from which point the Southeast corner of said Section 11 bears South 5°34' East Six Hundred Twenty-two and One-tenth (622.1) feet, and running thence North 57°12' West Fourteen and Nine-tenths (14.9) feet; thence North 89°53' West Five Hundred Eleven and Four-tenths (511.4) feet; thence South 0°07' West Five (5.0) feet to Station 5+55.0, a point on the South line of the Grantor's property, from which point the Southeast corner of said Section 11 bears South 43°09' East Eight Hundred Fifty-four and Three-tenths (854.3) feet, containing 0.24 of an acre, more or less.
