(hereinafter designated the "Declaration").

no change in any owner's undivided interest in the common area and facilities.

D. The owners of units within the Lodge at Snowbird authorize the amendment and modification of the Record of Survey Map of the Lodge at Snowbird to reflect (a) the common area which is hereby approved to become residential condominium units and (b) the residential condominium units which are hereby approved to become common area.

NOW THEREFORE, the parties hereto, as owners of the property which is the subject of the declaration hereby agree, state and authorize as follows:

1. The common area shown as 115, "ski lockers", on sheet three of the Record of Survey Map of the Lodge at Snowbird at page 5 in Book KK of the records of the Salt Lake County Recorder's office may be and become a residential unit within the Lodge at Snowbird, designated as Unit 115. Upon being made a residential unit, such unit shall have .58% ownership interest in the common area, the same percentage interest in the condominium as other units of similar size in the condominium. Such unit shall have one vote.

2. The common areas shown as 117 and 118, "sauna", on sheet three of the Record of Survey Map of the Lodge at Snowbird at page 5 in Book KK of the records of the Salt Lake County Recorder's office may be and become two residential units within the Lodge at Snowbird, designated as Unit 117 and Unit 118. Upon being made a residential unit, each such unit

shall have .58% ownership interest in the common area, the same percentage interest in the condominium as other units of similar size in the condominium. Each such unit shall have one vote.

- 3. Units 11 through 20 on the Pool Deck Level, as shown on Sheet 2 of the Record of Survey Map, are owned by the Association of Unit Owners of the Lodge at Snowbird. One cr more of such units, or portions thereof, may be converted to common area, in exchange for common area converted to residential units, as provided above, for any of the following purposes:
 - (a) ski entry;

- (b) ski lockers:
- (c) sauna and/or steam room and related facilities, including restroom facilities.

Subject to the provisions of paragraph 7(b), the undivided interests in the common areas of Units 11 through 20 which are not converted to common areas may be adjusted so that at all times the Association of Unit Owners shall have a constant percentage ownership interest in the common areas associated with the units it owns.

4. Any of the Units 11 through 20, or any portion thereof, which are not utilized as common area for the purposes designated in paragraph 3 may be retained as units and, in addition to or in place of their use as residential units, utilized in or incorporated into the Lodge Club facility, which

may include dining, lounge, kitchen, food service, and related facilities.

- 5. The Lodge Club facility, which is presently located in Units 111, 112, 113, and 114, may be residential units.
- 6. The Management Committee of the Association of Unit Owners of the Lodge at Snowbird may enter into such agreements or Authorize such work, modifications or changes to the designated common areas and the designated units to complete the work necessary to create and establish the common areas and residential units as authorized herein. The conversion provided for herein may be in whole, at one time, or in parts and from time to time until the entire conversion authorized herein is completed.
- 7. The Management Committee may execute and record such amendments to the Record of Survey Map and the Declaration as may be appropriate to indicate the actions authorized herein.
 - (a) In connection with paragraphs 1 and 2 hereof, Sheet 3 of the Record of Survey Map of the Lodge at Snowbird shall be amended upon the conversion, whether together or on separate occasions, to show Unit 115, Unit 117 or Unit 118 as residential condominium units and shall delete, as appropriate and upon the conversion, the references to "ski lockers" and "sauna," and the Record of Survey Map shall otherwise be modified consistent with this authorization and the purpose and intent of this Amendment and Authorization.

- (b) Exhibit A of the Declaration of the Lodge at Snowbird may be amended from time to time to allow an interest in the common area and a vote to be attributed to Unit 115, Unit 117, and Unit 118 in exchange for such interests in units owned by the Association of Unit Owners. Provided, however, that in no event shall an owner's total percentage ownership interest in the common area or the votes associated with the various units within the Lodge at Snowbird be altered or amended in connection with this Amendment and Authorization.
- 8. This Amendment to the Declaration may be executed in one or more counterparts, each of which, when executed and delivered, shall be an original and all of which shall together constitute one and the same instrument. Each owner authorizes the Management Committee or counsel for the Lodge at Snowbird to affix the signature page to one original form of this Amendment.

9. Upon execution of this Amendment by seventy-five percent (75%) of the total votes of the owners of the Lodge at Snowbird, this Amendment may be recorded in the office of the recorder of Salt Lake County, State of Utah, whereupon this Amendment, as implemented and supplemented as provided herein, shall become effective.


