A non-exclusive temporary easement, for purpose of constructing thereon an irrigation facility thereof necessary for the construction of road improvements of the extension of the existing highway State Route 193, Project Number S-0193(6)0, situate in the NE1/4SE1/4 of Section 3 in T.4N., R.2W., S.L.B.&M. and being part of an entire tract of property recorded as Entry 697722, Book 1027, Page 1102 in the office of the Davis County Recorder. This easement shall commence upon the beginning of actual construction on the property and shall continue only until project construction on the property is complete, or for three years, whichever first occurs. The easement shall be non-exclusive such that the Grantor may use the property at any time in a manner which does not interfere with construction activities. The boundaries of said part of an entire tract are described as follows:

Beginning at a point 67.00 feet perpendicularly distant southerly from the SR-193 control line at Engineer Station 143+89.00. Said point of beginning is 1,036.38 feet N.89°57'08"W. along the East-West Quarter section line of said section and 151.00 feet S.0°06'29"W. from the East Quarter Corner of said Section 3; and running thence as follows:
