THIRD AMENDMENT OF DECLARATION OF PROTECTIVE COVENANTS, AGREEMENTS, EASEMENTS CONDITIONS AND RESTRICTIONS FOR NINIGRET PARK NORTH

THIS THIRD AMENDMENT OF DECLARATION OF PROTECTIVE COVENANTS, AGREEMENTS, EASEMENTS CONDITIONS AND RESTRICTIONS FOR NINIGRET PARK NORTH (this "Amendment") is made by the Committee formed pursuant to that certain Declaration of Protective Covenants, Agreements, easements Conditions and Restrictions for Ninigret Park North, Recorded August 29, 2012, Entry No. 2683344, in Book 5595, Pages 69-87, as amended by that certain Amendment of Declaration of Protective Covenants, Agreements, Easements Conditions and Restrictions for Ninigret Park North, Recorded September 11, 2013, as Entry No. 2765650, Book 5850, Pages 715-724, as further amended by that certain Second Amendment of Declaration of Protective Covenants, Agreements, Easements Conditions and Restrictions for Ninigret Park North, Recorded December 11, 2014, as Entry No. 2838385, Book 6162, Pages 121 (collectively, the "Declaration"). All capitalized terms used and not otherwise defined herein shall have the meanings set forth in the Declaration.

RECITALS

- A. The Declaration currently encumbers that certain real property located in Davis County, Utah, as such is more particularly on <u>Exhibit A</u>, attached hereto and incorporated herein by this reference (the "Current Covered Property").
- B. Section 9.10 of the Declaration permits the Committee to execute and record an instrument amending the Declaration, upon approval by the Owners owning more than fifty percent (50%) of the total acreage of the Current Covered Property.
- C. Ninigret Construction Company North L.C., a Utah limited liability company ("Ninigret Construction"): (i) owns more than fifty percent (50%) of the total acreage of the

Current Covered Property; and (ii) has approved and consented to the withdrawal of certain real property from the Declaration.

NOW, THEREFORE, in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which hereby are acknowledged, the Committee hereby amends the Declaration as follows:

1. <u>Amendment</u>. The Declaration is hereby amended to provide that from and after the date of the recording of this Amendment in the official records of the Davis County Recorder, the Declaration will **ONLY** be applicable to the real property specifically described on Exhibit B, attached hereto and incorporated by referenced herein (the "Encumbered Property"). For clarification purposes, the Encumbered Property is already encumbered by the Declaration and will be the only real property encumbered by the Declaration.

All Property that is part of the Current Covered Property that is not part of the Encumbered Property (the "Withdrawn Parcel") is hereby released from the Declaration and the Declaration is hereby amended to provide that from and after the date of the recording of this Amendment in the official records of the Davis County Recorder, the Declaration will not be applicable to the Withdrawn Parcel.

- 2. <u>Approval by Ninigret Construction</u>. Ninigret Construction is the current fee owner of more than fifty percent (50%) of the Current Covered Property, which includes the Withdrawn Parcel. By signing below, Ninigret Construction approves and accepts that the Withdrawn Parcel will not be encumbered by the Declaration after the recordation of this Amendment.
- 3. <u>Effect of Amendment on Declaration</u>. Except as explicitly amended hereby, the Declaration is hereby ratified and confirmed in all respects and shall remain in effect in accordance with their original terms.
- 4. <u>Effective Date</u>. This Amendment will take effect on the date it is recorded at the office of the Davis County Recorder.
- 5. <u>Counterparts</u>. This Amendment may be executed in any number of counterparts, provided each counterpart is identical in its terms. Each such counterpart, when executed and delivered will be deemed to be an original, and all such counterparts shall be deemed to constitute one and the same instrument. For convenience in recording, signature pages from multiple counterparts may be detached from their counterparts and attached to a single counterpart to be recorded.
