DECLARATION OF PROTECTIVE COVENANTS AND RESTRICTIONS
FOR WESTGATE SUBDIVISION

WHEREAS, on October 27, 1955 the owners of all the property within Westgate Subdivision, located in Salt Lake County, made, entered into, executed and recorded certain Protective Covenants and Restrictions for Westgate Subdivision, as manifested by the official record on file in the office of the County Recorder of Salt Lake County, Entry number 1453236 in Book 1252 of Official Records at page 639; and,

WHEREAS, such covenants and restrictions make no provision for necessary utility substations for the purpose of serving such subdivision and adjacent areas,

NOW THEREFORE, the undersigned, being desirous of amending said declaration, and being all the owners of any right, title or interest in or to such subdivision, in consideration of the premises do hereby amend said Declaration of Protective Covenants and Restrictions for Westgate Subdivision by adding thereto Paragraph K to read as follows:

"K. The provisions of these covenants and restrictions shall not apply to small utility substations provided such substations are neat and well kept and all above ground equipment is housed within the substation building; and provided further that all such buildings and facilities therein are situated within the rear forty (40) feet of any lot within the subdivision."
