- 2. <u>Common Area and Facility After Declarant Ceases to be Unit Owner.</u>
 Pursuant to Utah Code Ann. Section 57-8-13.14, at such time as the Declarant ceases to be a Unit Owner, the Sales Area shall become a Common Area and Facility, subject to all the terms and conditions that apply to Common Areas and Facilities under the Declaration, as amended.
- 3. <u>Full Force and Effect</u>. Except as contained herein, the remainder of the Declaration shall remain unamended and in full force and effect.
