Jane E. B. Doxey, Nora D. Cox, Myrtle D. Hope, Leo S. Doxey, Paul D. Doxey, Alma T. Doxey, Jr., Orpha G. Doxey, grantors of Clearfield, County of Davis, State of Utah, hereby grants, bargains and sells to the STATE ROAD COMMISSION OF UTAH, Grantee, for the sum of Two Hundred 00/00 DOLLARS, the following described right of way across the grantor land in Davis County, State of Utah as follows:

Right of way for highway known as F.A. Project No. 114-C across the grantors land in the NE 1/4 SE 1/4 of Section 35, T. 5 N., R. 2 W., S.L.M. Said right of way is contained within a strip of land 50 ft. wide, on the west side of the center line of survey of said project. Said center line is described as follows:

Beginning at the intersection of the south boundary line produced of said grantors land and said center line of survey at Engineer's Station 286+30, which point is 2315.0 ft. north along the east line of said Section 35 from the SE corner of said Section 35; thence N. 0° 04' E., 333.5 feet to the intersection of said center line of survey at Engineer's Station 289+63.5 and the north line of said SE 1/4 of Section 35, which point is also the east 1/4 corner of said Section 35, as shown on the official map of said project on file in the office of the State Road Commission of Utah. Above described tract of land contains 0.38 acre, of which 0.26 acre is now occupied by the existing highway. Balance 0.12 acre.

In executing this deed, the grantors hereby grant to the State Road Commission of Utah permission to relocate and reconstruct within the grantors land and outside the limits of above described right of way, all irrigation ditches existing within said limits of above described right of way.

The purpose of this deed is to grant a perpetual right of way for highway purposes.

Harvey L. Moore and Hattie M. Moore grantors of Clearfield, County of Davis, State of Utah, hereby grants, bargains and sells to the STATE ROAD COMMISSION OF UTAH, Grantee, for the sum of Five Hundred Twenty-two and 50/100ths DOLLARS, the following described right of way across the grantors land in Davis County, State of Utah as follows:

Right of way for highway known as F.A. Project No. 59 across the grantors land in the SE $\frac{1}{4}$ SW $\frac{1}{4}$  of Section 1, T. 4 N., R. 2 W., S.L.M. Said right of way is contained within a parcel of land 45.0 ft. wide, 45.0 ft. on the southwesterly side of the center line of survey of said project. Said center line is described as follows:

Beginning at the intersection of the south boundary line produced of said grantors land and said center line of survey at Engineer's Station 216+12, which point is 1217.5 ft. north and 730.3 ft. west from the south  $\frac{1}{4}$  corner of said Section; thence N. 41° 41' W., 145.0 feet, to the intersection of said center line of survey at Engineer's Station 217+57 and the north line of said SE $\frac{1}{4}$  SW $\frac{1}{4}$  of Section 1, which point is 1325.7 ft. north and 826.7 ft. west from said south  $\frac{1}{4}$  corner of Section 1, as shown on the official map of said project on file in the office of the State Road Commission of Utah. Above described parcel of land contains 0.15 acre, of which 0.10 acre is now occupied by the existing highway. Balance 0.05 acre.

In executing this deed, the grantor hereby grants to the State Road Commission of Utah permission to relocate and reconstruct within the grantors land and outside the limits of above described right of way, all irrigation ditches existing within said limits of above described right of way, and to extend onto said grantor's land and outside the limits of above described right of way all cut and/or fill slopes made necessary by the grading for sidewalks on said project.
