**FIRST AMENDMENT TO THE BYLAWS OF
PROSPECTOR SQUARE CONDOMINIUMS**

This First Amendment to the Bylaws of Prospector Square Condominiums ("First Amendment to the Bylaws") is executed this 24 day of July, 2006, by Prospector Square Condominiums Association of Unit Owners, Inc. (the "Association"), a Utah non profit corporation, acting by and through the Association and its Management Committee.

RECITALS

1. WEHEREAS Section XIV of the Bylaws of Prospector Square Condominiums ("Bylaws") provides that the Bylaws of Prospector Square Condominiums ("Bylaws") as set forth in Appendix B of the Declaration may be amended by an instrument in writing signed and acknowledged by Unit Owners holding 75 percent of the total voting power;

2. WHEREAS the Association at an annual meeting of the membership, duly noticed and held on June 24, 2006, this First Amendment to the Bylaws was approved and adopted by a vote of Unit Owners of the Association holding at least 75 percent of the total voting power of the Association;

3. WHEREAS the purpose of this First Amendment to the Bylaws is to amend Section VI of the Bylaws to clarify that the Management Committee shall be allowed and authorized pursuant to Section I.I.E of the Bylaws to make special assessments against individual Unit Owners whose units are affected by capital improvements to the Common Areas as defined in the Declaration of Covenants, Conditions and Restrictions or Prospector Square Condominiums as amended ("Declaration"); and

4. WHEREAS due to safety concerns the Management Committee desires to make capital improvements to the Common Areas including replacement of sliding glass doors and installation of heating units to select units that require maintenance, repairs or upgrades.

AMENDMENT TO BYLAWS

NOW THEREFORE, be it resolved that the following provisions are hereby adopted and incorporated into the Bylaws, as follows:

1. The above Recitals are incorporated herein by reference;

2. A new Subsection C shall be amended to, and incorporated in, Section VI of the Bylaws, and shall read as follows:

C. Special Assessments

In addition to the Assessments authorized above, the Management Committee may levy Special Assessments (without limitation as to amount or frequency) against one or more individual Units and their Owners to reimburse the Association, for the purpose of defraying, in whole or in part, the cost of any labor, maintenance, construction, reconstruction, upgrade, repair or replacement, and any other similar or related costs of capital improvements upon both the Limited Common Areas and the Common Areas, or to defray any unanticipated or underestimated expense not covered by the Regular Assessment, and, where necessary, to satisfy taxes or fees assessed against the Common Areas.

3. To the extent that this First Amendment to the Bylaws conflicts with any provision of the Declaration as amended to date the provision of this First Amendment to the Bylaws shall control.

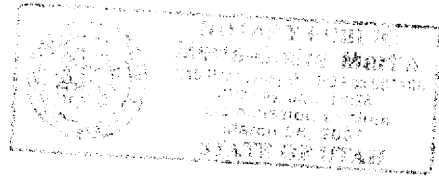
