### **NOTICE OF REVISED REINVESTMENT FEE COVENANT**

The Buyer of a Unit at Powderwood at Landmark Condominium shall be required to pay to the Powderwood Homeowners Association at the time of closing or settlement of the sale of his or her Unit a Reinvestment Fee in a sum to be determined by the governing board pursuant to Article III, ¶ 3 of § 17 of the Declaration of Condominium of Powderwood at Landmark Condominium recorded in the office of the County Recorder of Summit County, Utah on June 28, 1984 as Entry No. 222015 in Book 304 at Page 184 of the official records, as amended and supplemented (the "Declaration").

This notice affects the real property located in Summit County, Utah described with particularity on Exhibit "A" attached hereto and incorporated herein by this reference (collectively "Land" or Units and individually "Unit").

The Board of Directors, using its business judgment, will determine the amount of the fee, which is subject to change based upon market conditions and the needs of the Association. The amount of the Reinvestment Fee may not exceed 0.5% of the value of the Unit at the time of closing or settlement and shall comply with the requirements of Utah Code Ann., Section 57-1-46(5) (2010) as amended or supplemented (the "Act").

The name of the association of Unit owners responsible for the collection and management of the Reinvestment Fee is the Powderwood Homeowners Association (the "Association") whose principal place of business is 1777 Sun Peak Dr., Park City, Utah 84098, P.O. Box 980845, Park City, Utah 84098.

The Reinvestment Fee Covenant is intended to run with the Land and to bind successors in interest and assigns thereof. The duration of the Reinvestment Fee Covenant is perpetual. The Reinvestment Fee required to be paid hereunder shall benefit the Land and Units. No other transfer, community investment, or reinvestment fees on the Land or any Unit are allowed.

The Reinvestment Fee Covenant may not be enforced upon: (1) An involuntary transfer; (2) A transfer that results from a court order; (3) A bona fide transfer to a family member of the seller within three degrees of consanguinity who, before the transfer, provides adequate proof of consanguinity; (4) A transfer or change of interest due to death, whether provided in a will, trust, or decree of distribution; (5) The transfer of the Lot by a financial institution except to the extent that the Reinvestment Fee Covenant requires the payment of the Association's costs

directly related to the transfer of the lot or unit, not to exceed \$250.00, as that amount may be amended by statute from time to time; or any other transfer prohibited by the Act.
