AGREEMENT AMENDING Paragraph 4 (a) of the PROTECTIVE COVENANTS AFFECTING LOTS IN MORTON MEADOWS PLAT "C" - - -

The undersigned, being the owners of all Lots in MORTON MEADOWS PLAT "C", HEREBY amend Paragraph 4 (a) of the Declaration of Building and Use Restrictions recorded May 6, 1970 as Entry No. 2331416, Book 2854, Page 186 of Official Records, to read as follows:

> 4. Building Location. (a) No building on any lot nearer to the front lot line or nearer to the side street line than the minimum building setback lines shown on the recorded plat. In any event no building shall be located on any lot nearer than 20 feet to the front lot line, or nearer than 20 feet to any side street line.
