## AMENDMENT TO THE DECLARATION OF PROTECTIVE COVENANTS FOR THE WYNDOM HIGHLANDS NO. 1 SUBDIVISION

### KNOW ALL MEN BY THESE PRESENTS:

THAT WHEREAS, WYNDOM HIGHLANDS BOARD OF TRUSTEES HAS CERTIFIED THAT BY A MAJORITY VOTE OF THE HOMEOWNERS OF THE WYNDOM HIGLANDS NO.1 SUBDIVISION HOMEOWNERS ASSOCITION THE FOLLOWING AMENDMENT HAS BEEN APPROVED.

A Declaration of Protective Covenants for the WYNDOM HIGHLANDS NO. 1 SUBDIVISION, dated July 17, 1997, was previously recorded on October 17, 1997, as Entry #1354515 in Book 2189 and Page 265 with the Davis County Recorder (the "CC&Rs").

# These covenants have been amended as follows:

#### Residential ARA Covenants

#### 3. Dwelling cost, Quality, and Size.

d. The front exteriors of all dwellings shall be at least thirty percent (30%) brick, cultured or natural stone veneer.

The front exterior shall be a combination of either brick and stucco or stone and stucco.

The exterior balance shall be of high-quality aluminum siding or stucco in traditional earth tones indigenous to the area.

d. The front exterior, of all dwellings, shall be at least thirty percent (30%) brick, cultured or natural stone veneer, or stone, or rock. The remaining front exterior shall be either stucco or fiber cement siding in traditional earth tones in harmony with the homes in the subdivision.

The remaining exterior balance may include any combination of brick, stone, rock, stucco, aluminum, or vinyl siding, or fiber cement siding.
