Beginning in the north right of way line of the existing North Temple Street at a point approximately 896 ft. north and 80 ft. west from the SE corner of said Section 35; thence N. 0°16'29" E. 916.46 ft., more or less, along the east line of said entire tract to a point 80.0 ft. perpendicularly distant westerly from the centerline of 5600 West Street at Engineer Station 48+00; thence N. 89°43'31" W. 30.0 ft.; thence S. 2°48'00" W. 680.84 ft.; thence S. 82°26'50" W. 242.86 ft.; thence S. 73°32'16" W. 276.67 ft.; thence S. 65°19'02" W. 295.34 ft., more or less, to said north right of way line at a point 78.79 ft. perpendicularly distant north-westerly from the centerline of "B" Line of said project at Engineer Station 16+55.85; thence S. 89°48' E. 833.30 ft., more or less, to the point of beginning.
