

ACKNOWLEDGMENT, CONSENT AND FORBEARANCE

THIS ACKNOWLEDGMENT, CONSENT AND FORBEARANCE (this "Consent"), is made effective as of the day of June, 2021, by and between CHAD SALMON, an individual resident of the State of Utah, NORTH VILLAGE ASSOCIATES, LLC, a Utah limited liability company ("NVA"), NORTH VILLAGE DEVELOPMENT, LLC, a Utah limited lability company ("NVD") and RANDY KRANTZ, an individual resident of the State of Utah ("Krantz"). NVA, NVD and Krantz shall be referred to herein collectively as "North Village Parties".

The NOW, THEREFORE, for and in consideration of the premises contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged and confessed, the parties hereto, intending to be legally bound hereby, do hereby covenant and agree as follows:

1. INTRODUCTION:

- a. The North Village Parties made specific representations to Salmon to induce him into entering into that certain Membership Unit Purchase Agreement dated March 6, 2017 between NVA and Salmon ("MUPA".
- b. To date, the North Village Parties have not performed pursuant to the terms of the MUPA and is in default.

2. ACKNOWLEDGEMENT, CONSENT & FORBEARANCE:

- a. The North Village Parties desire a three month period, from the date first entered above, in which a deal may be restructured with Salmon ("Forbearance Period").
- b. Salmon agrees to forbear the filing of any court action to enforce the terms of the MUPA during the Forbearance Period. Should Salmon and the North Village Parties be unable to reach an agreement, upon the expiration of the Forbearance Period, Salmon may, in his sole discretion, seek any available legal remedy to enforce the terms of the MUPA.
- c. The North Village Parties acknowledge the need for and consent to Salmon recording a Notice of Interest on any real estate owned by NVA and NVD.

3. MISCELLANEOUS.

a. <u>Amendments</u>. This Consent may not be modified, amended, altered or supplemented, except upon the execution and delivery of a written agreement executed by the parties hereto.

- 4. <u>Governing Law</u>. This Agreement shall be governed by and construed in accordance with the laws of the State of Utah, regardless of the laws that might otherwise govern under applicable principles of conflicts of laws thereof.
- 5. <u>Counterparts</u>. This Agreement may be executed in two or more counterparts, each of which shall be deemed to be an original, but all of which shall constitute one and the same Agreement.
