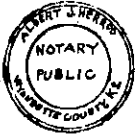

Salt Lake City, a municipal corporation under the laws of Utah grantor, for One (\$1.00) Dollar and other consideration, convey and Quit-Claims unto Edward Laird, grantee, of Salt Lake City, Utah, the following described property in Salt Lake City, Salt Lake County, State of Utah:

Commencing 186.14 feet west of the southeast corner of Lot 1, Block 1, 5-Acre Plat A, Big Field Survey, running thence west 55.75 feet; thence north 2° 30' east 287.37 feet; thence east along the north line of said Lot 1, 55.75 feet; thence south 2° 30' west 287.37 feet to the place of beginning, containing 0.368 acres.

Also
