EASEMENT

This Easement is executed by Sugar House Properties, LLC, a Utah limited liability company, of 600 North East Capital Street, Salt Lake City, Utah 84103 in favor of Pinecone Properties, L.C., a Utah limited liability company, of 1063 East 2100 South, Salt Lake City, Utah 84105.

Recitals:

- A. Sugar House Properties, LLC is the owner of the real property located in Salt Lake County, Utah described in Exhibit A, attached hereto, hereinafter described as the "Sugar House Property."
- B. Pinecone Properties, L.C. is the owner of the real property located in Salt Lake County, Utah described in Exhibit B attached hereto (the "Pinecone Property"), which is located directly east of and contiguous to the Sugar House Property.
- C. Pinecone Properties, L.C. is remodeling its building and requires this Easement to meet Salt Lake City requirements in order to place windows in the west wall of its building, which is located adjacent to the lot line with the Sugar House Property.

Easement:

t. Creation of Pasement. Sugar House Properties, LLC hereby grants to Pinecobe Properties, L.C. an easement on the terms set forth below over the following described tract of land:

A strip of land eleven feet in width on the east edge of the Sugar House Property beginning at the north edge of the existing building located on the southeast corner of the Sugar House property, and running to the north boundary of the Sugar House Property.

2. Scope of Easement. The easement created herein is a negative easement that Sugar House Properties, LLC and its successors and assigns shall not build or construct any building in the easement area during the term of the easement.

- 3. Termination. Sugar House Properties, LLC and its successors and assigns reserve the right to terminate this easement by giving Pinecone Properties, L.C. or its successors or assigns thirty days advance written notice of termination and recording a notice of termination with the Salt Lake County Recorder's office. Upon termination, Pinecone Properties, L.C. and its successors and assigns agree to block the windows on the west side of the building if necessary for the building to comply with Salt Lake City building requirements.
- 4. Appurtenance. The Easement created by this Agreement shall be appurtenant to the Pinecone Property.




