EASEMENT

The undersigned, Grantors and property owners in Davis County, State of Utah, for one dollar and other good and valuable consideration, hereby grant to Davis County, a body politic, a perpetual easement for storm water, in that certain stream known as Howard Slough which flows across and/or borders Grantor's property, together with a reasonable right to clean and maintain the same as needed. Said stream as it affects the undersigned property owners, is more particularly described as follows:

A stream that flows into Davis County at the common boundry of Weber County and Davis County at a point which is North 1700 ft., more or less, along the section line and West 500 ft. more or less along the County line from the SE corner of Section 19, Township 5 North, Range 2 West, Salt Lake Meridian. The stream flows in a southwesterly direction through the SE 1/4 of Section 19, the NE 1/4 of Section 30, and the NW 1/4 of Section 30, Township 5 North, Range 2 West; and the NE 1/4 of Section 25, the SE 1/4 of Section 25, the SW 1/4 of Section 25, the NW 1/4 of Section 36, and the NE 1/4 of Section 35, Township 5 North, Range 3 West, Salt Lake Meridian, and flows westerly to the Great Salt Lake.

Also, the south arm of the Howard Slough which originates in the SE 1/4 of Section 30, Township 5 North, Range 2 West, Salt lake Meridian, and flows westerly through the SE 1/4 of Section 30, and the SW 1/4 of Section 30, Township 5 North, Range 2 West and the SE 1/4 of Section 25, Township 5 North, Range 3 West, to the point of confluence with the main arm of the Howard Slough.

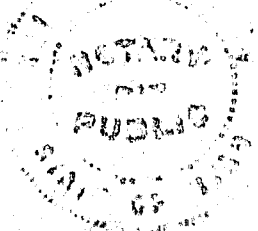
