KNOW ALL MEN BY THESE PRESENTS:

The undersigned, being all of the owners of the following described property situate in the County of Salt Lake, State of Utah, towit:

All of Lots 401 to 421, inclusive, MOUNT OLYMPUS PARK NO. 4, a subdivision according to the plat thereof, recorded in the office of the County Recorder of said County. Excepting therefrom all of Lots 416, 417, 419 and 421, the same having been amended by and included within the boundaries of MOUNT OLYMPUS COVE, according to the official plat thereof.

do hereby amend those certain "Dedication of Restrictive Covenants MOUNT OLYMPUS PARK SUBDIVISION NO. 4" recorded April 2, 1957, in Book 1402, at page 164 of Official Records as follows:

Paragraph "C" is hereby amended to read as follows:

C. No building shall be located on any residential building plot nearer than 40 feet to the front lot line, provided however that said setback may be 30 feet on Lots 406, 407, and 408, and 420 and 20 feet on Lots 402, 403, 404, and 405, provided, said 20 feet setback is approved and allowed by the Salt Lake County Zoning Board. No building except a detached garage or other outbuilding located 60 feet or more from the front lot line shall be located nearer than 25 feet to any side lot line or side street line provided, however, that with reference to Lots 402, 403, 404, 405, 406 and 407, no building except a detached garage or other outbuilding located 60 feet or more from the front lot line shall be located nearer than 15 feet to any side lot line. Except Lot 408 - no building shall be located less than 10 feet to the north side line.

Paragraph "D" is hereby amended to read as follows:

D. No residential structure shall be erected or placed on any building plot, which plot has an area of less than 20,000 square feet or a width of less than 100 feet at the front building setback line, provided however that a residential structure may be erected on Lots 420, 403, 409,410, which has an area of approximately 17,000 square feet.
