THIS INDENTURE, made this 3/st day of December, 1958, between BAMBERGER RAILROAD COMPANY, a Utah corporation, Party of the First Part, and THE DENVER AND RIO GRANDE WESTERN RAIL-ROAD COMPANY, a Delaware corporation, duly qualified to do business in the State of Utah, Party of the Second Part, WITNESSETH:

That the said Party of the First Part, for and in consideration of

One Hundred Dollars (\$100.00), to it in hand paid by the Party of the Second

Part, and for other good and valuable considerations, the receipt and


sufficiency whereof is hereby acknowledged, has granted, bargained, sold

and conveyed and by these presents does hereby grant, bargain, sell and

convey unto the Party of the Second Part, its successors and assigns

forever, all those certain tracts or parcels of land situate in the County of

TO HAVE AND TO HOLD the same, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining, unto the Party of the Second Part, its successors and assigns forever.

And the First Party, for itself, its successors and assigns, covenants with said Party of the Second Part, its successors and assigns, that, except as hereinabove set forth, the above granted and described premises are free from all encumbrances made or suffered by the Party of the First Part, and the Party of the First Part will, and its successors and assigns shall, except as to any encumbrance hereinabove set forth, warrant and defend the same to the said Party of the Second Part, its successors and assigns forever against the lawful claims and demands of all persons claiming by, through or under the Party of the First Part.
