

STATE OF UTAH, County of WEBER, State of UTAH, hereinafter
known as Grantor, hereby conveys unto the UNITED STATES OF AMERICA,
acting pursuant to the provisions of the Act of June 17, 1902 (32 Stat.,
168) and acts amendatory thereof or supplementary thereto, Grantee, for
the sum of One Dollar (\$1.00), a perpetual easement to construct, re-
construct, operate and maintain an underground pipeline or pipelines
and appurtenant structures which latter may protrude above the ground
on, over or across the following described property in Weber County,
State of Utah:

A strip of land in the Southwest Quarter of the Northwest
Quarter (SW¹/₄) of Section Fifteen (15), Township Five
(5) North, Range One (1) West, Salt Lake Base and Meridian,
Twenty (20.0) feet wide and included between two lines
extended to the property lines and everywhere distant Ten
(10.0) feet on the right or North side and Ten (10.0) feet
on the left or South side of that portion of the following
described centerline of what is known as the Uintah Bench
Lateral h.l.l. from Station 25+33.4 to Station 26+71.0 measured
at right angles thereto; said centerline is more particularly
described as follows:

Beginning at Station 25+33.4, a point on the East line of the
Grantor's property from which point the Northwest corner of
said Section 15 bears North 6°05' West Thirteen Hundred Forty-
four and Three-tenths (1344.3) feet, and running thence North
89°50' West One Hundred Twenty-six and Eight-tenths (126.8)
feet; thence South 45°10' West Five and Nine-tenths (5.9)
feet; thence North 89°44' West Four and Nine-tenths (4.9)
feet, to Station 26+71.0, also being a point on the West
line of the Grantor's property from which point the North-
west corner of said Section 15 bears North 0°17' West
Thirteen Hundred Forty and Five-tenths (1340.5) feet, con-
taining 0.63 of an acre, more or less.
