For and in consideration of the sum of three hundred forty-seven dollars and fifty cents (\$347.50) to be paid to the Grantors by the Grantee upon the acceptance of this instrument, we, Myron B. Child and Mable C. Child, his wife, Grantors, hereby grant and convey to the United States of America, Grantee, and its assigns a perpetual easement to construct, operate, maintain, repair and replace pipe lines and appurtenances for the conveyance of sewage from or under a portion of the land owned by the Grantors situated in the County of Davis, State of Utah, more particularly described as follows:

PARCEL NO. 59

A strip of land twenty (20) feet wide, lying ten (10) feet (measured at right angles) on each side of a center line which is described as follows:
