This Deed of Trust dated November 30, 2018 (the "Security Instrument"), by and among BENJAMIN COBB and LONI COBB, husband and wife, maintaining an address at 1097 North Heritage Hills Drive, Alpine, UT 84004 ("Trustor," as defined below) granting to FIRST AMERICAN TITLE INSURANCE COMPANY, 215 South State Street, #280, Salt Lake City, Utah 84111, as trustee ("Trustee," as defined below), for the benefit of NEWTEK SMALL BUSINESS FINANCE, LLC, a New York limited liability company maintaining an address at 1981 Marcus Avenue, Suite 130, Lake Success, NY 11042, as beneficiary (the "Lender").

Trustor, simultaneously herewith, has guaranteed payment and performance of a loan made to Microplex Co. and Third Market LLC (the Borrower, as defined below) by the Lender in the principal amount of Six Hundred Sixty Thousand and 00/100 (\$660,000.00) Dollars evidenced by a certain note dated the date hereof (the "Note") secured by a guaranty given by the Trustor to the Lender (the "Guaranty"); and

WHEREAS, the Trustor intends to secure the Guaranty with this Deed of Trust.

This Deed of Trust shall constitute a:

(a) valid lien on the real Property, fixtures (and hazard insurance related to the same), proceeds of title insurance and condemnation awards related to the Deed of Trust on premises described on Schedule "A" attached hereto;

#### **DEFINITIONS**

- (A) "Security Instrument" means this document, which is dated November 30, 2018, together with all Riders to this document.
- **(B)** "Borrower" is Microplex Co., a Delaware corporation maintaining an address at 1097 N. Heritage Hills Drive, Alpine, UT 84004, and Third Market LLC, a Montana limited liability company maintaining an address at 1097 N. Heritage Hills Drive, Alpine, UT 84004 and a place of business at 244 Spokane Avenue, Whitefish, MT 59937.
- (C) "Trustor is Benjamin Cobb and Loni Cobb, husband and wife, maintaining an address at 1097 North Heritage Hills Drive, Alpine, UT 84004.
- (D) "Lender" is Newtek Small Business Finance, LLC. Lender is an SBA Licensed Lending Institution organized and existing under the laws of the State of New York. Lender's address is 1981 Marcus Avenue, Suite 130, Lake Success, NY 11042. Lender is the beneficiary under this Security Instrument.
- (E) "Trustee" is First American Title Insurance Company, 215 South State Street, #280, Salt Lake City, Utah 84111.
- (F) "Note" means the promissory notes signed by Borrower and dated November 30, 2018. The Note states that Borrower owes Lender Six Hundred Sixty Thousand and 00/100 (\$660,000.00) Dollars plus interest. The maturity date on this debt is ten (10) years and one (1) month from the date of the Note.
- (G) "Property" means the property that is described below under the heading "Transfer of Rights in the Property" and in Schedule A.
- (H) "Loan" means the debt evidenced by the Note, plus interest, any prepayment charges and late charges due under the Note, and all sums due under this Security Instrument, plus interest.
- (I) "Applicable Law" means all controlling applicable federal, state and local statutes, regulations, ordinances and administrative rules and orders (that have the effect of law) as well as all applicable final, non-appealable judicial opinions.
- (J) "Community Association Dues, Fees, and Assessments" means all dues, fees, assessments and other charges that are imposed on Borrower or the Property by a condominium association, homeowners association or similar organization.
- (K) "Electronic Funds Transfer" means any transfer of funds, other than a transaction originated by check, draft, or similar paper instrument, which is initiated through an electronic terminal, telephonic instrument, computer, or magnetic tape so as to order, instruct, or authorize a financial institution to debit or credit an account. Such term includes, but is not limited to, point-of-sale transfers, automated teller machine transactions, transfers initiated by telephone, wire transfers, and automated clearinghouse transfers.
- (L) "Escrow Items" means those items that are described in Section 3.

the Property; (iii) conveyance in lieu of condemnation; or (iv) misrepresentations of, or omissions as to, the value and/or condition of the Property.

- (N) "Mortgage Insurance" means insurance protecting Lender against the nonpayment of, or default on, the Loan.

UNIFORM COVENANTS. Trustor and Lender covenant and agree as follows:

1. Payment of Principal, Interest, Escrow Items, Prepayment Charges, and Late Charges. Trustor shall pay when due the principal of, and interest on, the debt evidenced by the Note and any prepayment charges and late charges due under the Note. Trustor shall also pay funds for Escrow Items pursuant to Section 3. Payments due under the Note and this Security Instrument shall be made in U.S. currency. However, if any check or other instrument received by Lender as payment under the Note or this Security Instrument is returned to Lender unpaid, Lender may require that any or all subsequent payments due under the Note and this Security Instrument be made in one or more of the following forms, as selected by Lender: (a) cash; (b) money order; (c) certified check, bank check, treasurer's check or cashier's check, provided any such check is drawn upon an institution whose deposits are insured by a federal agency, instrumentality, or entity; or (d) Electronic Funds Transfer.

In the event of loss, Trustor shall give prompt notice to the insurance carrier and Lender. Lender may make proof of loss if not made promptly by Trustor. Unless Lender and Trustor otherwise agree in writing, any insurance proceeds, whether or not the underlying insurance was required by Lender, shall be applied to restoration or repair of the Property, if the restoration or repair is economically feasible and Lender's security is not lessened. 9. Protection of Lender's Interest in the Property and Rights Under this Security Instrument. If (a) Trustor fails to perform the covenants and agreements contained in this Security Instrument, (b) there is a legal proceeding that might significantly affect Lender's interest in the Property and/or rights under this Security Instrument (such as a proceeding in bankruptcy, probate, for condemnation or forfeiture, for enforcement of a lien which may attain priority over this Security Instrument or to enforce laws or regulations), or (c) Trustor has abandoned the Property, then Lender may do and pay for whatever is reasonable or appropriate to protect Lender's interest in the Property and rights under this Security Instrument, including protecting and/or assessing the value of the Property, and securing and/or repairing the Property. Lender's actions can include, but are not limited to: (a) paying any sums secured by a lien which has priority over this Security Instrument; (b) appearing in court; and (c) paying reasonable attorneys' fees to protect its interest in the Property and/or rights under this Security Instrument, including its secured position in a bankruptcy proceeding. Securing the Property includes, but is not limited to, entering the Property to make repairs, change locks, replace or board up doors and windows, drain water from pipes, eliminate building or other code violations or dangerous conditions, and have utilities turned on or off. Although Lender may take action under this Section 9, Lender does not have to do so and is not under any duty or obligation to do so. If this Security Instrument is on a leasehold, Trustor shall comply with all the provisions of the lease. If Trustor acquires fee title to the Property, the leasehold and the fee title shall not merge unless Lender agrees to the merger in writing.

Mortgage Insurance. If Lender required Mortgage Insurance as a condition of making 10. the Loan, Trustor shall pay the premiums required to maintain the Mortgage Insurance in effect. If, for any reason, the Mortgage Insurance coverage required by Lender ceases to be available from the mortgage insurer that previously provided such insurance and Trustor was required to make separately designated payments toward the premiums for Mortgage Insurance, Trustor shall pay the premiums required to obtain coverage substantially equivalent to the Mortgage Insurance previously in effect, at a cost substantially equivalent to the cost to Trustor of the Mortgage Insurance previously in effect, from an alternate mortgage insurer selected by Lender. If substantially equivalent Mortgage Insurance coverage is not available, Trustor shall continue to pay to Lender the amount of the separately designated payments that were due when the insurance coverage ceased to be in effect. Lender will accept, use and retain these payments as a non-refundable loss reserve in lieu of Mortgage Insurance. Such loss reserve shall be non-refundable, notwithstanding the fact that the Loan is ultimately paid in full, and Lender shall not be required to pay Trustor any interest or earnings on such loss reserve. Lender can no longer require loss reserve payments if Mortgage Insurance coverage (in the amount and for the period that Lender requires) provided by an insurer selected by Lender again becomes available, is obtained, and Lender requires separately designated payments toward the premiums for Mortgage Insurance. If Lender required Mortgage Insurance as a condition of making the Loan and Trustor was required to make separately designated payments toward the premiums for Mortgage Insurance, Trustor shall pay the premiums required to maintain Mortgage Insurance in effect, or to provide a non-refundable loss reserve, until Lender's requirement for Mortgage Insurance ends in accordance with any written agreement between Trustor and Lender providing for such termination or until termination is required by Applicable

Law. Nothing in this Section 10 affects Trustor's obligation to pay interest at the rate provided in the Note.

Mortgage Insurance reimburses Lender (or any entity that purchases the Note) for certain losses it may incur if Trustor does not repay the Loan as agreed. Trustor is not a party to the Mortgage Insurance.

Mortgage insurers evaluate their total risk on all such insurance in force from time to time, and may enter into agreements with other parties that share or modify their risk, or reduce losses. These agreements are on terms and conditions that are satisfactory to the mortgage insurer and the other party (or parties) to these agreements. These agreements may require the mortgage insurer to make payments using any source of funds that the mortgage insurer may have available (which may include funds obtained from Mortgage Insurance premiums).

As a result of these agreements, Lender, any purchaser of the Note, another insurer, any reinsurer, any other entity, or any affiliate of any of the foregoing, may receive (directly or indirectly) amounts that derive from (or might be characterized as) a portion of Trustor's payments for Mortgage Insurance, in exchange for sharing or modifying the mortgage insurer's risk, or reducing losses. If such agreement provides that an affiliate of Lender takes a share of the insurer's risk in exchange for a share of the premiums paid to the insurer, the arrangement is often termed "captive reinsurance." In the event of a total taking, destruction, or loss in value of the Property, the Miscellaneous Proceeds shall be applied to the sums secured by this Security Instrument, whether or not then due, with the excess, if any, paid to Trustor.

In the event of a partial taking, destruction, or loss in value of the Property in which the fair market value of the Property immediately before the partial taking, destruction, or loss in value is equal to or greater than the amount of the sums secured by this Security Instrument immediately before the
