AGREEMENT

A PLANNED UNIT DEVELOPMENT"

This agreement entered into on this ____ day of October, 2002, is by and between KDAB, LLC, a Utah Limited Liability Company (hereafter referred to as "Declarant") and the current individual owners of Lots in the "Oaks at Deer Hollow, Phase I, A Planned Unit Development," Tooele City, according to the official subdivision plat map thereof on file in the office of the County Recorder, Tooele County, State of Utah (hereafter "The Oaks").

Whereas Declarant is the owner and developer of "The Oaks" and currently owns 22 lots at "The Oaks," some of which have been built upon and some of which are vacant Lots and;

Whereas, the individual lot owners of "The Oaks" currently own ______ lots with residential improvements on said lots within "The Oaks," and;

Whereas, Declarant currently has through the Declaration of Covenants, Conditions and Restrictions and By-Laws of "The Oaks", the ability to cast a majority of votes to elect the Board of Trustees of the Homeowners Association and;

Whereas, Declarant is no longer interested in controlling the Homeowners Association and has agreed to relinquish at least two of the three positions on the Board of Trustees of the Association with their replacements to be appointed from the individual Lot owners and;

Whereas, the individual Lot owners are prepared to assume the management of the Association by having at least two persons from its members being appointed to the Board of Trustees of the Homeowners Association.

NOW THEREFORE, in consideration of the promises specified herein, the parties agree as follows:

1. Declarant agrees within 30 days of the date of this agreement to cause at least two members of the current Board of Trustees of "The Oaks at Deer Hollows, Homeowners Association Inc.", to resign their positions and that their successors be appointed from the individual members and Lot owners, not including those of Declarant. Declarant also has the option of causing all three of the current members of the Board of Trustees to resign and that their replacements also be from the individual members and Lot owners to be elected in the above referenced manner. Declarant agrees that it will not vote for or pursue more than one member on the Board of Trustees of the Homeowners Association, from and after the date of this Agreement.

- 1. Declarant and the individual Lot owners, agree that a special meeting of the Homeowners Association owners shall be called within thirty days of the effective date of this agreement and that at least two members and three if required, shall be elected to the Board of Trustees of the Homeowners Association pursuant to the By-Laws and that these new members of the Board of Trustees shall immediately take part in the management of "The Oaks".
- 2. This agreement shall take effect when signed by Declarant and ninety percent (90%) of the individual Lot owners of "The Oaks", other than Declarant.
- 3. This agreement is binding upon the heirs, executors, administrators, successors and permissible assigns or respective parties hereto.
