AN ORDINANCE OF OGDEN CITY, UTAH, CHANGING THE NAME OF 25<sup>TH</sup> STREET TO HISTORIC 25<sup>TH</sup> STREET FROM WASHINGTON BOULEVARD TO WALL AVENUE; AND PROVIDING THAT THIS ORDINANCE SHALL BECOME EFFECTIVE IMMEDIATELY UPON POSTING AFTER FINAL PASSAGE.

WHEREAS, the Historic 25 Association, Inc., has petitioned to change the name of 25<sup>th</sup> Street running westerly from Washington Boulevard to Wall Avenue in order to provide a more universal method of identification of a major historic area of Ogden City;

WHEREAS, the Ogden City Planning Commission has reviewed such petition and recommends approval of the street name change as petitioned;

WHEREAS, such petition has also been reviewed by the City Engineer, the Police Department and the Fire Department in conjunction with the Planning Commission review;

WHEREAS, the Ogden City Council has determined, after notice and hearing as provided by State law and city ordinance that the name change will not be detrimental to the public interest and that good cause exists for the name change.

## NOW THEREFORE, the Council of Ogden City hereby ordains:

SECTION 1. Street Name Changed. The public street heretofore designated as "25<sup>th</sup> Street" as such street runs in a westerly direction from Washington Boulevard to Wall Avenue shall hereafter be designated as "Historic 25<sup>th</sup> Street."

**SECTION 2.** <u>Notification of Name Change.</u> The City Recorder is hereby directed to record this ordinance in the office of the Weber County Recorder and provide a copy of such ordinance to the City Engineer who shall notify the U.S. Postal Service and area emergency service providers.

**SECTION 3.** Payment of Costs of Change. The expenses incurred by the city relating to the name change shall be borne by the petitioner and coordinated with related City agencies.

**SECTION 4.** <u>Design of Street Signs.</u> Where applicable, the new "Historic 25<sup>th</sup> Street" street signs should use brown and white colors and bear the Ogden City Landmarks logo as other historic districts within the City.

SECTION 5. Effective date. This Ordinance shall become effective immediately upon

posting after final passage.
