AMENDMENT TO RESTRICTIONS

KNOW ALL MEN BY THESE PRESENTS:

The undersigned, being all of the owners of the following described property situate in the County of Salt Lake, State of Utah, to-wit:

All of Lots 1 to 15, inclusive, CLIFF VIEW, a subdivision according to the plat thereof, recorded in the office of the County Recorder of said County.

do hereby amend those certain "Building Restrictions" recorded October 2, 1950, in Book 803 at page 374 of Official Records, and those certain "Amended Building Restrictions" recorded November 14, 1950, in Book 814 at page 559 of Official Records as follows:

Paragraphs "1." are hereby amended to read as follows:

1. Each and every lot above described shall be known and is hereby designated as a "Residential Lot" and no structure shall be erected, altered, placed or permitted to remain on any such "Residential Lot" other than one detached single-family dwelling not to exceed two stories in height and a private garage for not more than three automobiles, except that one detached two-family dwelling or duplex may be erected and shall be permitted to remain on Lot 15 of said subdivision.
