MOTIONTWO Patro Covers. The company is Sun Setter Retractable Awnings. The cost would be \$1018.00. The colog requirement will be white and taupe The model IS #1000XT and 14' X 10' from Sunsetter Retractable awnings at (800) 876-2340

MOTION THREE White storm doors. Storm doors must be white and must be purchased from Home Depot. The brand is Forever All Seasons door and the model number is WH20214.

MOTION FOUR Privacy fences. White vinyl fence sections will be allowed for privacy. They must be installed on the sides of the patio. There can be no permanent fence across the back enclosing the patio. The panel must be white vinyl. Maximum panel size is 6' x 12' (six high by 12 feet long) The cost of each panel at this time at Home Depot is \$336.00. It will be up to each homeowner to purchase these. The owners should contact the next door owner to discuss shared cost.

MOTION FIVE . Increasing patio sizes. Patio sizes can be increased to a maximum of 12' \times 14'. Increases can be by concrete or patio payers
